Welcome to the first edition of our new ENOC Newsletter. ENOC Bureau recent activities

The ENOC Bureau spoke by teleconference early in November as there were a number of activities ongoing. The following decisions were agreed at that meeting:

2009 ENOC Annual Conference

The 2009 ENOC Annual Conference will be held in Paris. A potential date may be **23-25 September** (to be confirmed by Dominique Versini).

This event will coincide with the 20th anniversary of the UN CRC.

The title and themes of the Conference will be taken during the Bureau meeting which will be held on December 8th, 2008.

I have been in contact with Rimante who has been gracious about this as I know she was keen to host the conference in Vilnius. Rimante has asked me to inform you of their conference in Vilnius on December 15th (see upcoming events for more details).

EU Fundamental Rights and Citizenship Programme

A new application has been made to the European Commission for funding for 2009 through the Fundamental Rights and Citizenship Programme. This application is for \in 100k. If we are successful, our intention is to enhance the ENOC Secretariat by appointing someone to work with Polina in a co-ordination role of our work across Europe. The application was submitted on November 13th. I have spoken with Guido Lanzke, the programme manager, who tells me that we can expect to hear in the early part of 2009. I will let you know as soon as we hear.

The 2008 funding has been issued very late and will be used to reimburse existing projects or work already carried out. There are **two outstanding commitments** made under 2008 application for funding through the EU Fundamental Rights and Citizenship Programme. A mapping exercise on child participation and a thematic seminar on child participation.

The Seminar will focus on child participation thus including a first evaluation of the recently launched ENOC comparative study on the same topic. We are currently working on the Seminar Programme. In due time, it will be circulated to EU/ENOC members by email.

On this matter, we would like to recall all members that the deadline for submitting the questionnaire was November 28th. We strongly encourage all colleagues to participate in this initiative and send their responses ASAP to Polina.

Visit to Croatia

On behalf of ENOC, Polina (Strasbourg Secretariat) carried out from November 18th to 22nd a three day field visit to Croatia. She visited the Office of the Ombudsperson for Children of the Republic of Croatia and met with Mila Jelavic, the Ombudsperson for Children, the two deputies and the staff members.

19 November: After 5 years of existence, the Office of the Ombudsperson for Children of Croatia launched on its own initiative an external evaluation of the work accomplished by the Office in relation to legislation, competence, means of reporting, authority and effective independence, accompanied by an assessment of effectiveness achieved at the individual and general levels. Thus, the Office approached, as external evaluators, experts from Croatia and abroad, representing UNICEF, the UN Committee on the Rights of the Child, and experts from the field of psychology and constitutional and family law. On November 19th, a presentation of the experts' evaluation of the work of the Office took place in the Parliament of the Republic of Croatia. The staff members of the Ombuds Office and Polina attended the presentation.

20 November: Together with Mila Jelavic and three staff members of the Office, Polina visited a technical high school in Zagreb where she met with 30 pupils. The aim of the visit was to discuss with the pupils (16-17 years old) about their difficulties in school and in applying to the upcoming university entrance exams.

21 November: Together with Mila Jelavic and the half of the staff from the central office (Zagreb), Polina visited the regional office in Osijek (250 km away from Zagreb) and attended a panel discussion on professional training in high schools.

My sincere thank you to Mila and her staff for their warm welcoming and generosity of time during this visit.
