Update on ENOC activities

Launching among ENOC members of the ENOC questionnaire on the respect of the rights of children/young people in institutional care

The respect of the rights of children and young people living in institutional care is on the 2011 agenda of ENOC. In this sense, a detailed questionnaire covering a large range of rights and situations has been prepared and circulated to all ENOC members. The survey pursues the following objective: to develop an overall picture of existing legal frameworks/reglementations and their shortcomings; existing and/or suggested good practices; main difficulties and challenges to make sure the rights of children/young people living in institutional care are fully respected; practical (critical/positive) assessment of adopted practices/measures; and different initiatives and projects carried out by ENOC member institutions in their respective countries/regions.

ENOC members are expected to provide as detailed as possible feedback on the questionnaire before the ENOC expert compiles the answers in a report that will be presented during the upcoming ENOC Annual meeting in Warsaw, Poland.

Those ENOC members that have a particularly relevant experience or interest on the topic may form a working group to support the ENOC expert in order to produce more tangible results.

Migration of the ENYA e-forum

It is expected that the four series of the common draft recommendations that resulted from the work done throughout the previous year are posted on the e-forum for further discussion by and among the young people.

Update on International and European Activities in the children's rights field

EC Communication on "An EU Agenda for the Rights of the Child" adopted

On February 15, the European Commission adopted a Communication setting an EU agenda for reinforcing the rights of the child by putting the principles of the EU Charter of Fundamental Rights into practice. It includes a series of concrete actions where EU can provide added value to policies for children's well-being and safety, including promotion of child-friendly justice, better informing children about their rights, and making the internet safer for them. Thus, the EU agenda lists 11 actions that the Commission will take over the coming years to achieve the above objectives.

Update on the draft OP to the CRC

The third drafting meeting for the complaints mechanism took place on 10-16 February 2011, in Geneva. After tense discussions and debates, the Chairperson (of the OEWG) made a surprising announcement and proposed a take-it-or-leave-it package. Among others, the Chair suggested that the draft Optional Protocol allow States to "opt-out" of applying the complaints mechanism to existing Optional Protocols, remove the collective communications mechanism, allow States to "opt-out" of participating in the inquiry procedure, and allow for reservations. This proposal generated a very strong reaction by all the stakeholders but especially by the Committee of the Rights of the Child and its President and Vice-President. Resolution of the European Parliament on international adoption in the EU

Adoption, and where necessary international adoption, should be encouraged, so as to give children who are abandoned or at risk of becoming institutionalized in orphanages a family life, said the EP in a resolution adopted on January 19, 2010. The resolution, stresses the need to protect a child's right to a family life and preclude the need for long stays in orphanages or other institutions. Adoption or an alternative family care solution, such as foster and residential care, should preferably take place in the child's country of origin. Failing this, an adoptive family should be found in another EU Member State, says the text. Placing a child in institutional care should be the very last option and also a temporary one it adds. EC Communication on "Early Childhood Education and Care: Providing all our children with the best start for the world of tomorrow" adopted

On February 17, the EC adopted a communication on early childhood education and care which proposes important measures aimed at providing all children with "the best start for the world of tomorrow". Most importantly, it acknowledges the contribution of early childhood services to children's emotional, social and cognitive development. The Communication recognises the valuable contribution that early childhood education and care services can bring to achieve the Europe 2020 Strategy headline targets to reduce the share of early school leavers to under 10% and to lift at least 20 million people out of the risk of poverty and social exclusion. It furthermore proposes a number of issues for policy cooperation between member states with a particular focus on inclusion and professionalization of staff. Crucially the Commission proposes to encourage member states to make use of Structural Funds to increase the accessibility and quality of early childhood services. "Migrant children should not be detained", a Human Rights Comment published by CoE Commissioner for Human Rights, Thomas Hammarberg

While detention of migrant children, even very small children, accompanied or not, remain a widespread practice within Europe despite the CoE, UN' and EU's clear prohibition of detention of minors in the migration context, the psychological harm and the fear and uncertainty detained migrant children are facing, the lack of access to education and to health services violate children's most basic rights, said the Commissioner. He also expressed concerns as to the lack of data and available statistics as to the exact number of detained migrant minors in Europe. The Commissioner thus invited states' governments to find alternative solutions without having recourse to detention, thus quoting a few positive steps that go in this direction, initiated by Belgium and the UK. Council of Europe "One in Five" campaign to stop sexual violence against children

In order to achieve further signature, ratification and implementation of the Council of Europe Convention on the protection of children against sexual exploitation and sexual abuse but also to equip children, their families/careers and societies at large with the knowledge and tools to prevent and report sexual violence against children, a "One to Five" campaign is operating in reference to one in five children in Europe being victim of some form of sexual violence.

In this context, a number of materials including campaign posters & postcards, a publication on many aspects of sexual violence, a handbook, a children's book, TV spots but also the "Underwear Rule" has been developed as a support for the campaign. Moreover, the Council of Europe joined forces with the UN and its Special Representative on violence against children to combat sexual violence against children through international standards.
