# ENOC Paris Conference: annual updates by member institutions

# Update on International and European activities in the field of children's rights

The 08 Summit of Ombudspersons for Children, Nuoro, Italy

"The impact of financial crisis and climate change on children"

Ombudspersons for Children or similar independent human rights institutions from all G8 countries (Canada, France, Germany, Italy, Japan, the Russian Federation, the United Kingdom and the United States) have met in Nuoro, Sardinia (Italy) on 25-26 June for the 08 Summit to discuss the impact of the financial crisis and climate change on children, and issue recommendations to G8 leaders to address challenges. The event was organized by the Province of Nuoro, the UNICEF Innocenti Research Centre and the Association of the Provinces of the Mediterranean area (Arco latino). Two ENOC members participated at the summit: Ms Dominique Versini, Défenseure des enfants (Children's Defender) in France and Ms Patricia Lewsley, Northern Ireland Commissioner for Children and Young People.

At the outcome of the meeting, Ombudspersons for Children called on G8 leaders to:

- > Invest in national and global social protection;
- Address climate change now;
- Maintain and increase development cooperation;
- Mobilize human resources;
- Establish, increase, maintain, and reinforce Ombudspersons for Children in more countries and regions.

### World Appeal to a New Mobilization on Childhood

BICE (the International Catholic Child Bureau), together with distinguished experts, civil society and academics launched on 4 June 2009 in Geneva the World Appeal to a New Mobilization on Childhood intended to commemorate the 20<sup>th</sup> anniversary of the UN Convention on the Rights of the Child.

The Appeal is addressed to all stakeholders: States, organizations, media, religious and moral authorities as well as all persons of good will. It develops recommendations to each of them.

In particular, one of the recommendations addressed to States is to create and cooperate with independent institutions to monitor the rights of the child such as the Ombudspersons for Children.

The Appeal remains open to institutional and/or individual signature up to 20 November 2009.

The event also supported the Junior-8, an initiative promoted by UNICEF to be held from 4 to 12 July in Rome and L'Aquila, gathering adolescent representatives from the G8 countries and from 6 non-G8 countries who will present their views and recommendations to G8 leaders.

#### The 4<sup>th</sup> European Forum on the Rights of the Child, 18 June, Brussels

The 4th European Forum on the Rights of the child that took place in Brussels on 18 June 2009 focused on how to effectively address *child labour* using instruments the EU has at its disposal. Within the main theme of *child labour*, the Forum specifically focused on *social protection* and *corporate social responsibility*.

ENOC has been represented at the Forum by the following member institutions: Belgium (Flemish community), Greece, Cyprus, Finland, France, Hungary, Lithuania and Poland.

While Commissioner Jacques Barrot (Justice, Freedom and Security) presented the overall picture within the EU, Commissioner Benita Ferrero-Waldner (External relations and European neighborhood policy) presented the question of child labour from external prospective before concluding that child labour needs to be tackled at all levels and through concerted efforts from governments, international community, civil society, industry and social partners. It was underlined that the problem of child labour has a global character with some 250 million working children between the age of 5 and 14 and therefore no region is free of it.

In Europe and in the world exploitation of children includes commercial sexual exploitation, slavery and similar practices, exploiting children for illicit activities, child trafficking, begging and exploitation of street children, and employment of children under hazardous conditions.

International Conference on combating sexual exploitation of children in the Internet, 30 June 2009, Berlin (follow-up of the Rio Congress) "The protection of girls and boys against sexual violence in the new media"

The German federal Ministry for Family Affairs, in cooperation with UNICEF, Save the Children, and Innocence in Danger organized on **30 June 2009** in Berlin an European follow-up conference to the 3<sup>rd</sup> World Congress against sexual exploitation of children and adolescents that took place in November last year in Rio de Janeiro.

What impact does the sexualisation of society have on children and young people? What child and youth protection measures can be provided for the Internet? Which solutions have proved particularly fruitful in identifying and supporting victims and in dealing with youth offenders?

These questions and further steps have been discussed. In workshops, brief presentations and round table discussions current challenges have been identified and perspectives for Europe have been outlined.

In addition to the German Federal Minister for Family Affairs, Ursula von der Leyen, the Deputy Secretary General of the Council of Europe, Maud de Boer-Buquicchio, Europol Director Rob Wainwright, Germany's Federal Criminal Police Office President Jörg Ziercke were present as well as young people from various European countries.

A final declaration has been agreed upon at the outcome of the Conference.
