### ENOC 17<sup>th</sup> Annual Conference (Brussels): follow-up

The 17<sup>th</sup> ENOC Annual Conference on “*Children on the move: children first!*”, hosted by the Ombudsman for Children of the French Community in Belgium and ENOC Chair, Mr. Bernard De Vos, took place on 25-27 September 2013 in “*Les Ateliers des Tanneurs*”, Brussels, Belgium.

Bringing together over 100 participants, including ENOC member institutions, observer non-member Ombudsman institutions from within and outside Europe, International and European organizations, NGOs and recognized experts in the children’s rights field, the ENOC Annual Conference provided a forum for the exchange of concerns and experience in the protection and promotion of children’s rights in general and more specifically on the situation of “*children on the move*” at national and European level.

On the first day of the conference an exchange of views was organized with European Parliamentarians campaigning for better respect for children’s rights in Europe and beyond. On this occasion, the ‘10 min. teaser’ (<http://crin.org/resources/infoDetail.asp?ID=31828&flag=news>) of the ENOC documentary film on ‘*children on the move*’ was screened for the first time at the European Parliament.

The UN Committee on the Rights of the Child, the EU Fundamental Rights Agency, the UNHCR, the International Play Association, academics, researchers and international experts all had the chance to take part and address participants.

The Conference resulted in the adoption of:

- A common position statement on ‘*Children on the move: children first!*’ (<http://crin.org/enoc/papers/index.asp>, available in English, French, Greek and Serbian);
- A position paper on the situation of Syrian children in refugee camps (<http://crin.org/enoc/resources/infoDetail.asp?ID=31837&flag=news>), available in English, French and Serbian; and
- The official public release of the ENOC documentary film on “*Children on the move: children first!*” (<http://crin.org/enoc/resources/infoDetail.asp?ID=31870&flag=news>)

### Activities linked to the ENOC documentary film “*Children on the move: children first!*”

- ❖ The French version of the documentary film is screened from 23 to 29 October 2013 in the “*Aventure*” cinema in Brussels. A debate was organized for the evening of the 23rd of October, when the French version of the film was screened in avant-première, with the participation of Mr. Bernard De Vos, ENOC Chair and Belgium’s French speaking Ombudsman for Children.
- ❖ The ‘10 minute teaser of the ENOC documentary film will be screened at the Eurochild 2013 Annual Conference on the 13-15th November 2013 in Milan, Italy. The teaser will be presented by the ENOC Chair, Mr. Bernard De Vos. The full ‘52 minute version will be screened at the stand of Italy’s Ombudsman for Children & Adolescents, and ENOC Secretary.

## **SRSG launched a Child-Friendly Version of the 3<sup>rd</sup> Optional Protocol to the CRC on a Communications Procedure (OCP)**

*Raising understanding among Children and Young People on the OCP*, a child-friendly publication launched by the Special Representative of the Secretary-General on Violence against Children, was developed with the support and advice of children and young people from different regions of the world. It aims to support wide dissemination of the Protocol, raise children's awareness about their rights and enhance their confidence to speak up and seek support. ## **Update on European & International activities in the children's rights field**

### **European Parliament report on Member States' Policies on Children with Disabilities**

The comparative report looks at policies promoting the rights of children with disabilities in 18 EU countries. The study presents an overview of some of the major issues and obstacles faced by children with disabilities and their families as well as a legal analysis of the implementation of the main rights and principles recognized in the UN Convention on the Rights of the Child and in the Convention on the Rights of Persons with Disabilities. The report concludes that whilst there is a broad recognition of the rights of children with disabilities under national legal systems, their practical implementation is revealed to be problematic in most Member States, and the economic crisis is contributing to the removal and reduction of assistance in most Member States. ### **Child labour in Europe: a persisting challenge**

Council of Europe Commissioner for Human Rights, Mr. Nils Muižnieks recently released a human rights comment on child labour, which remains a serious problem in Europe and may be growing in the wake of economic crisis. While the subject remains taboo and data and statistics are very often missing, the Commissioner provided figures that show that in many Council of Europe countries children, even at a young age, are working. The Commissioner insisted that many countries are underestimating the problem and called on Governments to investigate, collect data about and monitor the situation. ### **Decisions concerning migrant children must always be based on their best interests**

Council of Europe Commissioner for Human Rights, Mr. Nils Muižnieks, remains extremely concerned regarding the situation of migrant children, especially those unaccompanied, separated or trafficked. Insisting on the unconditional primary consideration of the best interests of migrant children in all decisions affecting them, the Commissioner questioned the ongoing returns, voluntary or forced, in countries where some European countries run high risk projects--the so called "welcoming centre" in Afghanistan-- or to countries where the child no longer has any ties. ### **Austerity measures weaken human rights protection in Spain, said CoE Commissioner for Human Rights**

In a recent country visit report on Spain, CoE Commissioner for Human Rights pointed out the worrying growth of family poverty and serious deficiencies in the enjoyment of human rights by children as a result of important cuts in social, health and education budgets. ### **Council of Europe One in Five campaign: new video clip to raise awareness of sexual violence against children**

A two minute video-clip (<http://assembly.coe.int/nw/xml/News/News-View-EN.asp?newsid=4700&lang=2&cat=133>) passes the message to adolescents who are victims of sexual abuse about how important it is to talk about their experience if the situation is to improve. The clip shows the secret pact between the abuser and the minor; a pact which the latter needs to break. Talking about it to someone else is difficult, but is vitally important. This video clip is part of the CoE One in Five campaign: "About ONE in FIVE children falls victim to sexual violence. This child is weighed down by a terrible secret. YOU could be the one who listens and helps." A pilot project aiming at strengthening national policies to stop sexual violence against children has been launched in Cyprus as part of the One in Five campaign.
