# "Every child and young person should live in a supportive, protective and caring environment that promotes their full potential"

(64/142. Guidelines for the Alternative Care of Children, General Assembly, United Nations, 2010)

Although there is a growing global awareness about the significance of developing and implementing family-oriented policies and initiatives that aim to tackle the root causes of separation and empower families to fulfil their caregiving responsibilities, millions of children in Europe and worldwide continue to grow up deprived of parental care and separated from their families.

Despite a strong international and European framework and commitments to protect and promote the rights of children in alternative care, children without parental care or at risk of losing it, still experience violations of their human rights on a regular basis. Isolation from families and communities may deprive them of necessary care, leading to a lack of suitable support for their individual needs, instability in relationships, and an increased risk of falling victim to violence and abuse.

This year's ENOC Annual Conference will focus on the level of implementation of international and regional standards in the child

alternative care framework and the critical role played by Ombudspersons for Children to independently report and redress violations of children's rights in the context of alternative care.

The event will conclude ENOC's annual activities on the topic, which involve collaborative work from experts, ENOC members, and the young people participating in the European Network of Young Advisors (ENYA). Insights from these activities will be presented at the Conference and reflected in the related ENOC policy statement, subject to endorsement by the General Assembly.


On the same occasion, the ENOC-wide research conducted on the matter provides findings for ENOC members to examine and discover measures to strengthen the rights of children in alternative care. The meaningful participation of children with care lived experience is a key element in addressing shortcomings in the different care systems and this is fully reflected in this year's ENYA activities.

The expectations of ENYA Young Advisors will complement the research findings, as they will share their policy recommendations adopted during the ENYA Forum in July 2024. Key questions to be addressed include: What are the key challenges and barriers faced by children in alternative care in accessing their rights? What role can ICRIs play in monitoring and safeguarding them? How can the voices and experiences of children in alternative care be amplified and taken into account in policy and decision-making processes?

Ombudspersons and Commissioners for Children from across Europe and beyond, representatives of key European and International Governmental and Non-Governmental organisations, governmental authorities, professionals, experts and other relevant stakeholders are expected to actively participate in the event and to contribute to the Conference theme with their experience.


